The superintendent/designee will establish guidelines governing site visits to insure orderly operation of the educational process and the safety of students and staff.

**Disruption of Cooperative and NWESD 189 Operations**

The superintendent/designee or staff member in charge will direct a person to leave immediately if any person is:

- 1) Under the influence of controlled substances, including marijuana (cannabis) or alcohol; or
- 2) Disrupting or obstructing any NWESD 189 program, activity, or meeting; or
- 3) Threatening to do so or is committing, threatening to imminently commit; or
- 4) Inciting another to imminently commit any act which would disturb or interfere with or obstruct any lawful task, function, process or procedure of any student, official, classified or certificated staff member or invitee of the NWESD 189.
