BEHAVIOR MANAGEMENT IS A TOP CONCERN OF PUBLIC SCHOOLS

Come and learn strategies for understanding and intervening with more significant challenging behaviors in school settings!

Specifically, this workshop will tackle behavioral challenges for students who are non-responsive to Tier I efforts through an integrated Tier II system.

This multi-day training is intended for schools already implementing Tier I PBIS. The training is designed for schools that are ready to begin, reboot, or enhance support for Tier II implementation efforts. Particularly, those individuals or school-based teams who currently work with more complex, challenging behaviors are encouraged to attend.

TEAM MEMBERS

A building principal or assistant principal is a required team member! Other team members could include additional building administrators, teachers, counselors, paraeducators, bus drivers, coaches, building support, and related services staff. There is an expectation that all team members will attend all four days of training.

ABOUT THE PRESENTER

Dr. Flint Simonsen is an Associate Professor in the School of Education at Whitworth University. He earned his BS at Eastern Washington University, his MS at Northeastern University, and his PhD at the University of Oregon. He has worked extensively with over 200 schools across the State of Washington in their efforts to implement School-wide Positive Behavior Support.
