- Room 3A-3 > Division I #2 vs Division II #2 vs Wildcard #3

Championship Oral Round (2:15) -- Teams will report to the rooms listed below to compete for final places:

- Room 3A-1 > Semi-Final 1st Place Teams compete for 1st, 2nd, and 3rd Places.
- Room 3A-2 > Semi-Final 2nd Place Teams compete for 4th, 5th, and 6th Places.
- Room 3A-3 > Semi-Final 3rd Place Teams compete for 7th, 8th, and 9th Places.

Awards Presentation (at the conclusion of each Championship Oral Round) -- Trophies and plaques will be awarded to the placing teams by the reader/judge in the room of their Championship Oral Rounds immediately upon the conclusion of that round. (There will not be a general meeting to present awards.)
