Early occupancy shall be allowed up to thirty days (30) prior to August 1, 2010, so long as Tenant pays triple net expenses ("NNN") and utilities during the early occupancy period, as described in Sections 3 and 4 of the Original Lease.
- 2. The date in Section 22(a) of the Original Lease is hereby changed to July 1, 2010.
- 3. Except as expressly modified hereby, all terms of the Original Lease shall remain in full force and effect.
